#### **OUR MISSION**

To ensure the conservation, protection and recognition of the historic, natural and Aboriginal values of Maatsuyker Island.

#### **OUR VISION**

Maatsuyker Island is recognised locally, nationally and internationally as having unique heritage, natural and Aboriginal values where:

- Historic values and evidence of Aboriginal heritage are well conserved and protected by heritage listing.
- Natural values are healthy and free of impacts from invasive species and disease.
- These values are clearly reflected in a Maatsuyker Island Values Statement and the Tasmanian Wilderness World Heritage Management Plan.
- Volunteer programs and any visitation opportunities are small scale, well-managed and support conservation of the island's values.







#### To achieve this, it is important to FOMI that we:

- Acknowledge the Tasmanian Aboriginal people as the traditional and original owners, and continuing custodians of the island and support engagement with Tasmanian Aboriginal people and communities.
- Promote community understanding and appreciation of the island's values.
- Have enthusiastic, diverse and well-informed members and supporters.
- Have a mutually respectful, professional relationship with the land manager of the island: Tasmania Parks and Wildlife Service (PWS).
- Undertake volunteer work and activities that meet the workplace health and safety legislation requirements, policies and guidelines.
- Have the skills, expertise, sustained effort, and substantial input by FOMI's supporters and volunteers, that are recognised by the PWS.
- Conduct or facilitate impactful, respected, relevant research and information sharing projects.
- Are financially sustainable and our resources enable us to realise our vision.
- Have a long-term commitment to the island and effectively plan for committee succession.
- Have a strong working relationship with other Wildcare Inc. Branches.
- Engage with all relevant stakeholders to further our vision.

#### WHAT HAVE WE ACHIEVED?

#### Over the last two decades FOMI has:

- Contributed approximately \$100,000 per annum of volunteer inkind and funds to achieve the following, in partnership with the PWS:
  - o extensive and necessary work to weatherproof and restore the lighthouse tower and fittings.
  - o substantial work to bring the island's historic quarters up to a functional standard, including the internal fitting out of houses.
  - o annual systematic weed control (since 2004), including survey, mapping and reporting, resulting in a reduction in the areas and number of four target weeds (Blackberry, Veronica (prev. Hebe) elliptica, Montbretia and Californian Thistle).
  - o annual monitoring (since 2013) of the island's short-tailed shearwater breeding population.

- o documented historic objects located on and off the island.
- o acquired and restored significant off-island historic objects.
- o supported the PWS volunteer caretakers and artists in residence programs.
- Conversations and engagement with Tasmanian Aboriginal community on island values.
- Conducted 13 day-trips (2008-2019) to the island by boat to support the PWS volunteer caretaker program and to promote community connection and understanding of the island's importance.
- Continued development and sales of high-quality merchandise including the publication of a booklet and other education materials about Maatsuyker Island.
- Publicly shared the unique values of Maatsuyker Island with community through:
  - o displays and exhibitions 10 Days on the Island, Maritime Museum, Rosny School House and Rosny Library.
  - o events the Australian Wooden Boat Festival, Seafarers Festival and Wildcare Gathering.
  - o talks and information sharing National Parks and Wildlife Advisory Council, The Royal Society of Tasmania, the Lighthouse Conference, Landcare Tasmania Conference, Wildcare Gathering, U3A, the Island Ark Symposium and 'Off Island Yarning' and 'Pop Up Museum' jointly with other Wildcare groups.

#### FOMI Achievements 2021-2025

- Celebrated 20 years of FOMI with an exhibition and event at the Maritime Museum.
- Continued strong FOMI Committee, reviewed Committee structure and member engagement.
- Maintained strong and constructive working relationship with the PWS including an updated PWS Volunteer Program Plan, to include FOMI Strategic Plan priorities.
- Continued engagement with the Tasmanian Aboriginal community to better understand and protect island values.
- Delivered successful stalls at the Australian Wooden Boat Festival 2023 and 2025.
- Increased social media profile for wider community engagement.
- Jointly, with other Wildcare groups, particularly Friends of Tasman Island, held 'Off Island Yarning' and 'Pop Up Museum' events at Geilston Bay Boat Club.
- Maintained strong support from the Pennicott Foundation for the Weed Control and Shearwater Monitoring Programs.
- Commitment of ongoing sponsorship from Helicopter Resources for FOMI works on the island.
- Delivered all planned working bees, including through COVID challenges, adopting communicable illness safe procedures for ongoing application.
- Continued biannual weed control program resulting in reduced weed numbers and area of infestation of target weeds.
   Commissioned the Maatsuyker Island Weed Management Plan 2022-2027. Developed a relationship with the Tasmanian Herbarium to increase the knowledge of volunteers and inform the Weed Control Program.
- Continued biannual short-tailed shearwater breeding population monitoring, and purchased a specialised 'burrowscope' camera for the FOMI Shearwater Monitoring Program.
- Continued maintenance program including on the Lighthouse, internal building repair and painting of Quarters No 2 and Quarters No 3 and contribution to the clean-up and restoration of the Haulage Winch Shed and Quarters No 3 Foul Shed.
- Obtained lightstation objects including an original kerosene lamp, constructed lamp display and Haulage Winch Shed precinct display, assisted with catalogue of objects from the Haulage Winch Shed.
